<u>ORDER</u>

The Hon'ble High Court in its judgement read as Ist paper above has directed Government to issue orders granting approval to St. Tresa's TTI, Mulavana, Kollam for conducting TTC Course. However as a Writ Appeal filed by the Government against the various judgement of the Hon'ble High Court ordering the Government to grant approval to the TTIs was pending, only temporary approval was granted to St. Tresa's TTI for conducting TTC Course during the academic year 2008-09 vide GO read as 2nd paper above. Temporary approval granted for conducting TTC Course to the TTI was further extended for the years 2009-10 and 2010-2011 vide GOs read as 3rd & 4th paper above. Now it has been decided to grant permanent approval to St. Tresa's TTI Mulavana, Kollam.

Accordingly permanent approval is granted to St. Tresa's TTI Mulavana, Kollam to conduct TTC Course.

This order is issued in full compliance of the judgement dated 2/07/08 of the Hon'ble High Court in WP(C) No. 18974/08 and will be subject to final orders in the Writ Appeal No.1151/2009 filed by the Respondents in the said WP(C) No.18974/08.
